**DRUG AND ALCOHOL ASSESSMENT/
ANGER MANAGEMENT/MENTAL HEALTH CLASS REFERRAL**

The following is a list of providers for anger management classes and mental health counseling in the Fairfield County area. This list is not in any particular order nor does the Court make recommendations for any particular agency. Other providers are available. If you have insurance that will pay for this service and the agencies listed below are not covered by your insurance, a state-certified provider is acceptable.

The Court requires that you make contact with a program within 30 days of your sentencing date. Please notify your probation officer within this 30-day time frame as to which agency you have chosen and when your appointment is scheduled. It is the responsibility of the Defendant to communicate this information with the Probation Department. Failure to comply with this requirement could result in a motion to revoke probation being filed. Please, due to confidentiality, no calls from family members.

These agencies will require that you sign a release before they will communicate with the Court. It may be necessary for you to request this communication.

Most of these classes run 10 to 18 weeks, but they can run as long as 26 weeks depending upon the program. Normally the classes are held once a week depending on the provider.
