RANDOM SELECTION – NONCOMPLIANCE SUSPENSION
LIMITED DRIVING PRIVILEGES
ORC 4510.021B**

EXPLANATION OF PROCESS

RANDOM SELECTION SUSPENSION ORC 4509.101 (3)(C):

THE OHIO BUREAU OF MOTOR VEHICLES (BMV) SENDS NOTICES TO INDIVIDUALS FOR A RANDOM SAMPLING OF MOTOR VEHICLES REGISTERED IN THE STATE OF OHIO, TO PROVIDE PROOF OF INSURANCE. IF YOU RECEIVE THE BMV NOTICE OF SUSPENSION AND CANNOT PROVIDE PROOF OF FINANCIAL RESPONSIBILITY, YOUR DRIVING PRIVILEGES AND VEHICLE REGISTRATION PRIVILEGES WILL BE SUSPENDED. YOU MAY THEN PETITION TO THE COURT IN THE COUNTY IN WHICH YOU RESIDE FOR LIMITED DRIVING PRIVILEGES, DURING THE LICENSE SUSPENSION.

NONCOMPLIANCE LICENSE SUSPENSION ORC 4509.101 (A):

IF YOU RECEIVE A BMV NOTICE OF SUSPENSION FOR NONCOMPLIANCE IN PROVIDING PROOF OF FINANCIAL RESPONSIBILITY INSURANCE TO THE OHIO BUREAU OF MOTOR VEHICLES, AND IT IS YOUR FIRST OFFENSE, YOU ARE SUSPENDED INDEFINITELY UNTIL YOU PAY YOUR REINSTATEMENT FEE AND FINANCIAL RESPONSIBILITY INSURANCE (SR-22 OR BOND) IS FILED WITH THE OHIO BUREAU OF MOTOR VEHICLES.

IF YOU RECEIVE A BMV NOTICE OF SUSPENSION FOR NONCOMPLIANCE IN PROVIDING PROOF OF FINANCIAL RESPONSIBILITY INSURANCE TO THE OHIO BUREAU OF MOTOR VEHICLES, AND IT IS YOUR SECOND OFFENSE WITHIN FIVE YEARS OF THE VIOLATION, YOU MAY PETITION THE COURT FOR LIMITED DRIVING PRIVILEGES DURING THE BMV ONE-YEAR LICENSE SUSPENSION. THE COURT MAY GRANT YOU LIMITED DRIVING PRIVILEGES AFTER SERVING A 15-DAY HARD SUSPENSION TIME (NO PRIVILEGES FOR A 15-DAY PERIOD).

THREE OR MORE VIOLATIONS WITHIN FIVE YEARS OF NONCOMPLIANCE WITH THE OHIO BUREAU OF MOTOR VEHICLES WILL RESULT IN A BMV TWO-YEAR LICENSE SUSPENSION. YOU MAY PETITION THE COURT FOR LIMITED DRIVING PRIVILEGES. THE COURT MAY GRANT YOU LIMITED DRIVING PRIVILEGES AFTER SERVING A 30-DAY HARD SUSPENSION TIME (NO PRIVILEGES FOR A 30 DAY PERIOD).

TO FILE A PETITION, YOU WILL NEED TO:

- 1) COMPLETE THE ATTACHED PETITION**
- 2) PAY A FILING FEE OF \$70.00**
- 3) ATTACH PROOF OF INSURANCE IN THE FORM OF AN SR-22, WHICH YOU WOULD OBTAIN FROM YOUR INSURANCE AGENT**
- 4) ATTACH A COPY OF THE BMV NOTICE OF SUSPENSION**
- 5) PAY THE REQUIRED REINSTATEMENT FEES TO THE OHIO BUREAU OF MOTOR VEHICLES AND ATTACH A COPY OF YOUR PAID RECEIPT TO THE PETITION.**

YOUR PETITION WILL BE SUBMITTED TO THE COURT. IF THE COURT GRANTS YOU LIMITED DRIVING PRIVILEGES, THE CLERK'S OFFICE WILL NOTIFY YOU BY MAIL AND THE OHIO BUREAU OF MOTOR VEHICLES OF THE COURT'S DECISION. THIS PROCESS MAY REQUIRE UP TO TWO WEEKS TO COMPLETE. YOU SHOULD ALSO RECEIVE WRITTEN NOTIFICATION FROM THE OHIO BUREAU OF MOTOR VEHICLES.
