**DRUG AND ALCOHOL ASSESSMENT/  
ANGER MANAGEMENT/MENTAL HEALTH CLASS REFERRAL**

The following is a list of providers for anger management classes and mental health counseling in the Fairfield County area. This list is not in any particular order nor does the Court make recommendations for any particular agency. Other providers are available. If you have insurance that will pay for this service and the agencies listed below are not covered by your insurance, a state-certified provider is acceptable.

The Court requires that you make contact with a program by the date specified by your Probation Officer at intake. The Defendant will need to make contact with an agency within the number of days required by the Court and provide proof or information to the assigned Probation Officer. If the counseling agency has a waiting list, you will need to get your name on the waiting list for the next available appointment. **It is the Defendant's responsibility to return the Court paperwork to the Probation Officer by the specified deadline.** (Please, due to confidentiality, no calls from family members.)

These agencies will require that you sign a release before they will communicate with the Court/Probation Officer. It may be necessary for you to request this communication.
